- 1.1 Users acknowledge that the Operator processes the personal data provided by them for the purpose of providing Lessons and operating Platform in accordance with the legislation on processing and protection of personal data, in particular, but not exclusively, the European Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons, on the processing of personal data and on the free movement of such data and on repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as "GDPR"), Act No. 110/2019 Coll., on the processing of personal data, as amended, and any judicial or administrative interpretation of legislation relating to processing and protection of personal data, any guidelines, codes of conduct, or approved certification mechanisms issued by the Office for Personal Data Protection. Details regarding the processing of Users' personal data are provided by the Operator on the Platform.
- 1.2 Personal data means any information about an identified or identifiable natural person, in particular, the User or his contact person; an identifiable natural person is a natural person who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, a network identifier or to one or more specific elements of the physical, physiological, genetic, psychological, economic, cultural or social identity of that natural person.
- 1.3 The User acknowledges and agrees that the Operator will process the personal data provided in the scope of (i) name and surname, (ii) date of birth, (iii) telephone number and (iv) other identification and address data provided by the User. The Operator only processes personal data provided by the User.
- 1.4 The processing of personal data by the Operator is lawful, as at least one of the following conditions is always met:
 - (a) The User has given consent (or, where applicable, secured the consent of other relevant persons) to the processing of personal data pursuant to Article 6(1)(a) GDPR for one or more specific purposes;
 - b) the processing of the personal data is necessary for the performance of the contract or the implementation of measures taken prior to the conclusion of the contract at the request of the User pursuant to Article 6(1)(b) GDPR;
 - c) the processing of personal data is necessary for compliance with a legal obligation which the Operator is subject to;
 - d) the processing of personal data is necessary for the purposes of the legitimate interests of the Operator pursuant to Article 6(1)(f) GDPR.
- 1.5 The Operator processes personal data for the following purposes:
 - a) for the purpose of providing services and fulfilling the Operator's contractual obligations, the Operator may process personal data provided by the User or provided in the future by using its services. This processing of personal data is necessary for the performance of the contract;
 - b) The Operator may process personal data that are necessary to exercise possible claims of the Operator and also to protect the rights of the Operator, such processing of personal data is in legitimate interest of the Operator.
- 1.6 The Operator retains personal data for the purpose of providing the Services and fulfilling the contractual obligations under Article 15.5(a) above for the duration of the Agreement.

- 1.7 The Operator retains personal data for the purpose of protecting its rights under Article 15.5(b) above for as long as its legitimate interest continues.
- 1.8 The personal data provided by the User is stored by the Operator only for the period necessary to exercise the rights and obligations arising from the legal relations between the parties to the contract or until the withdrawal of consent to the provision of personal data (if such withdrawal of consent implies an obligation for the Operator to delete personal data). After this period, the personal data is deleted by the Operator.
- 1.9 Personal data provided by the User may be transferred by the Operator to other processors providing consulting, marketing and other services, but always in accordance with the above purposes.
- 1.10 Based on the rules set out in the GDPR, the data subject has, in particular, the right to:
 - a) access personal data;
 - b) rectify personal data or, where appropriate, restrict the procession;
 - c) erase personal data;
 - d) object to the processing of personal data;
 - e) personal data portability;
 - f) withdraw the consent to the processing of personal data;
 - g) lodge a complaint with the Office for Personal Data Protection, if he/she considers that the processing has violated his/her right to the protection of personal data during processing or a related legal regulation.
- 1.11 In order to exercise any of these rights, the User may contact the Operator via the contact details provided above. The Operator will provide Users with assistance in exercising their rights.
- 1.12 The Operator declares that he has taken appropriate technical and organizational measures to secure the personal data provided by the User.
- 1.13 The Operator declares that he has taken technical measures to secure the data storage and storage of personal data provided by the User in a paper form.
- 1.14 The Operator declares that only persons authorized by him have access to the personal data provided by the User.
